




Lift Up a Child's Voice

The Northern Hills Area CASA (NHCASA) Program was started in 1986 by the current presiding judge, the Honorable Judge Warren Johnson, and a task force of community members. NHCASA is an affiliate of the National Court Appointed Special Advocate program and abides by its guidelines.



CASA is central to fulfilling society's most fundamental obligation of making sure a qualified, compassionate adult will fight for and protect a child's right to be safe, to be treated with dignity and respect, and to learn and grow in the security of a loving family.



Today more than 900 CASA programs are in operation, with over 70,000 volunteers. Last year, NHCASA volunteers served over 14,000 hours advocating for over 130 local children. CASA volunteers offer trust and advocacy during complicated legal proceedings. As trained citizens appointed by the court, a CASA volunteer represents the best interests of a child in court. Children who have a CASA volunteer tend to spend less time in the foster care system than those who do not have Court Appointed Special Advocate representation.



The Northern Hills Area CASA Program relies on donations and fundraisers to continue providing services to abused and neglected children.
